Pronoun reference is the practice of making pronouns that clearly refer to the words they replace, while a pronoun takes the place of a noun and thus the pronoun must agree with the noun because it replaces in number and person. Some examples of pronoun references are: Everyone is studying hard for his or her exams. (A pronoun must agree in number with the noun it refers to) If a student studies hard, he or she should succeed.

Unclear pronoun reference occurs when a pronoun (often "it," "this," "that," or "they") could refer to more than one antecedent in a sentence. An antecedent is simply the word (or words) that a pronoun refers to. To avoid unclear pronoun reference, make sure that every pronoun you use refers clearly and unmistakably to ONE particular noun, or rewrite the sentence for increased clarity.
