~~The GSCP uses three levels of classification: OFFICIAL, SECRET and TOP SECRET. This is simpler than the old model and there is no direct relationship between the old and new classifications. "Unclassified" is deliberately omitted from the new model. Government bodies are not expected to automatically remark existing data, so there may be cases where organisations working under the new system still handle some data marked according to the old system.~~

Thus, if one holds a Top Secret security clearance, one is allowed to handle information up to the level of Top Secret, including Secret and Confidential information.

Information classification is a process in which organisations assess the data that they hold and the level of protection it should be given. Organisations usually classify information in terms of confidentiality – i.e. who is granted access to see it. A typical system will include four levels of confidentiality:

- This security classification is applied to information the unauthorized disclosure of which would cause exceptionally grave damage to NATO. (NOTE: The marking "COSMIC" is applied to TOP SECRET material to signify that it is the property of NATO. The term "NATO TOP SECRET" is not used.)
