2018 SOCIAL SECURITY CHANGES
Income thresholds will change in 2018. For people who earn above \$85,000, the categories for higher Part B IRMAA surcharges will change in the middle tiers as follows: Up to \$85,000 for single filers; up to \$170,000 for joint filers. \$85,001 to \$107,000 for single; \$170,001 to \$214,000 for joint.

The annual deductible amount for Medicare Part B (medical insurance) in 2018 was \$183 and will rise to \$185 in 2019. The Medicare Part B monthly premium rate for 2018 was \$134 per month and will rise to \$135.50 in 2019. For those receiving Social Security benefits, this premium payment is deducted from your monthly benefit check.

Parts of Medicare. Social Security enrolls you in Original Medicare (Part A and Part B). Medicare Part A (hospital insurance) helps pay for inpatient care in a hospital or limited time at a skilled nursing facility (following a hospital stay). Part A also pays for some home health care and hospice care.

Medicare Benefits | SSA - Social Security Administration
The standard monthly premium for Medicare Part B enrollees will be \$134 for 2018, the same amount as in 2017. However, a statutory "hold harmless" provision applies each year to about 70 percent of enrollees. For these enrollees, any increase in Part B premiums must be lower than the increase in their Social Security benefits.
